Roll-Back

Despite significant efforts over the post-crisis years to increase economic convergence in the EU, the European Monetary Union (EMU) still falls short on three fronts: first, it is not yet able to reverse sufficiently the social and economic divergences between and within euro area members that emerged from the crisis. Second, these centrifugal forces come with a heavy political price. If they remain unaddressed, they are likely to weaken citizens' support for the euro and create different perceptions of the challenges, rather than a consensus on a vision for the future. Finally, while the EMU is stronger, it is not yet fully shock-proof. Overcoming these three shortfalls requires political courage, a common vision and the determination to act in a common interest. Main themes of discussion will include potential risks of an incomplete EMU, the process and preferred focus of convergence in the EU; a common fiscal capacity with stabilisation tools to absorb macroeconomic shocks; the democratic accountability issue and the future of EU institutional structure within the EU.
